1. Welcome and apologies

3. Report from the Parish Council

4. Matters arising from the Regulation 14 Consultation

All are encouraged to study the document and contact theme convenors with their views. - Observatory Hill is likely to be the most difficult issue to resolve. It will be important to get right the descriptions of the characteristics of LGS to avoid misunderstandings. It will be important to keep an eye on DCC's designation of much of this area as one of High Landscape Value.
- Concern was expressed about the tenor of the email from Stuart Timmiss addressed to the Parish Councillors on 4 July. It was agreed that we should seek a face-to-face meeting with him to express our views. The attendees would be Roger and John A as Parish Councillors, the Parish Clerk, and John L as Secretary to the NPWP. Roger and John A would ask the Clerk to write a holding letter to ST asking for the meeting. Then we would draft a full response to be considered by the PC's Planning Committee and then the full PC. We would meet specially on Tuesday 23 July to prepare this.

5. Tasks and Timetable to Complete the Neighbourhood Plan

John L had prepared a detailed list and schedule of tasks with the aim of obtaining final approval from the PC on 26 September as agreed at our previous meeting. It was now **agreed** that this was too tight and it should be 24 October. This would allow more time for the various stages of consideration required by the PC's Planning Committee as well as the full PC. A revised schedule is at the end of these notes.
